Minors, i.e., anyone under the age of eighteen (18) must have a parent and/or guardian sign on their behalf

ACKNOWLEDGEMENT OF RISK, RELEASE OF LIABILITY AND INDEMNIFICATION AGREEMENT

I understand that participation in the Goldstock 2025 at Camp Weequahic is not without risk, and the possibility of harm or damage to myself, my dog or my property. Although health and safety precautions will be taken, factors such as the personality of a dog, the level of dog handling experience of others, the various types of physical activity, and the unpredictable nature of animals pose certain levels of risk beyond the control of GOLDSTOCK 2025. Neither Goldstock 2025 nor Camp Weequahic assumes any responsibility for any aspect of the safety of human participants, dogs or property. My participation in camp is done voluntarily and in full recognition of the risks to me and my dog, which risks I agree to fully assume while in attendance at Camp Weequahic.

Therefore, in consideration of my participation in GOLDSTOCK 2025 at Camp Weequahic, and for other valuable consideration, the receipt of which is hereby acknowledged, I, the undersigned, individually and/or as parent or guardian of my minor child/children, if applicable, hereby and forever release, discharge and hold harmless and indemnify GOLDSTOCK 2025 and Camp Weequahic, its employees, officers, directors, agents, contractors, and volunteers from any and all actions, cause of action and claims for personal injury or property damage, regardless of cause, including negligence on account of or in any way growing out of directly or indirectly, actions of myself, my dog or others participating in, conducting or in attendance at GOLDSTOCK 2025.

I hereby certify that the foregoing statements made by me are true and correct and that GOLDSTOCK 2025 and Camp Weequahic have relied upon the truthfulness of information I provided in order to allow me and my dog/dogs, and minor child/children to participate in GOLDSTOCK 2025.

1. I am the parent/guardian of a child under 18 years of age (if applicable).
2. I have been fully informed of all the rules and policies of GOLDSTOCK 2025 and I agree to abide by all such rules at all times.
3. I understand the control of my dog is always my sole responsibility.
4. I have no medical or physical conditions which would prevent me or my dog in participation of any activities. I certify that my dog is healthy and free from contagious disease.
5. I have kept a copy of the RELEASE.

6. I understand that any time my dog or I behave inappropriately, GOLDSTOCK 2025 and Camp Weequahic have the right to dismiss my dog and me from the premises, without refund.

7. I agree to be responsible for any damage caused by me or my dog to Camp Weequahic property, lodging facilities or property of others while at camp.

8. I understand that the use of the lake is at my own risk for myself and my dog.

9. I will permit GOLDTOCK 2025 the free use of my name and pictures in any GOLDSTOCK materials.

10. All dogs must be vaccinated with age appropriate vaccines, including but not limited to rabies. Rabies cert must be provided on request.
